GOVERNANCE / OVERSIGHT



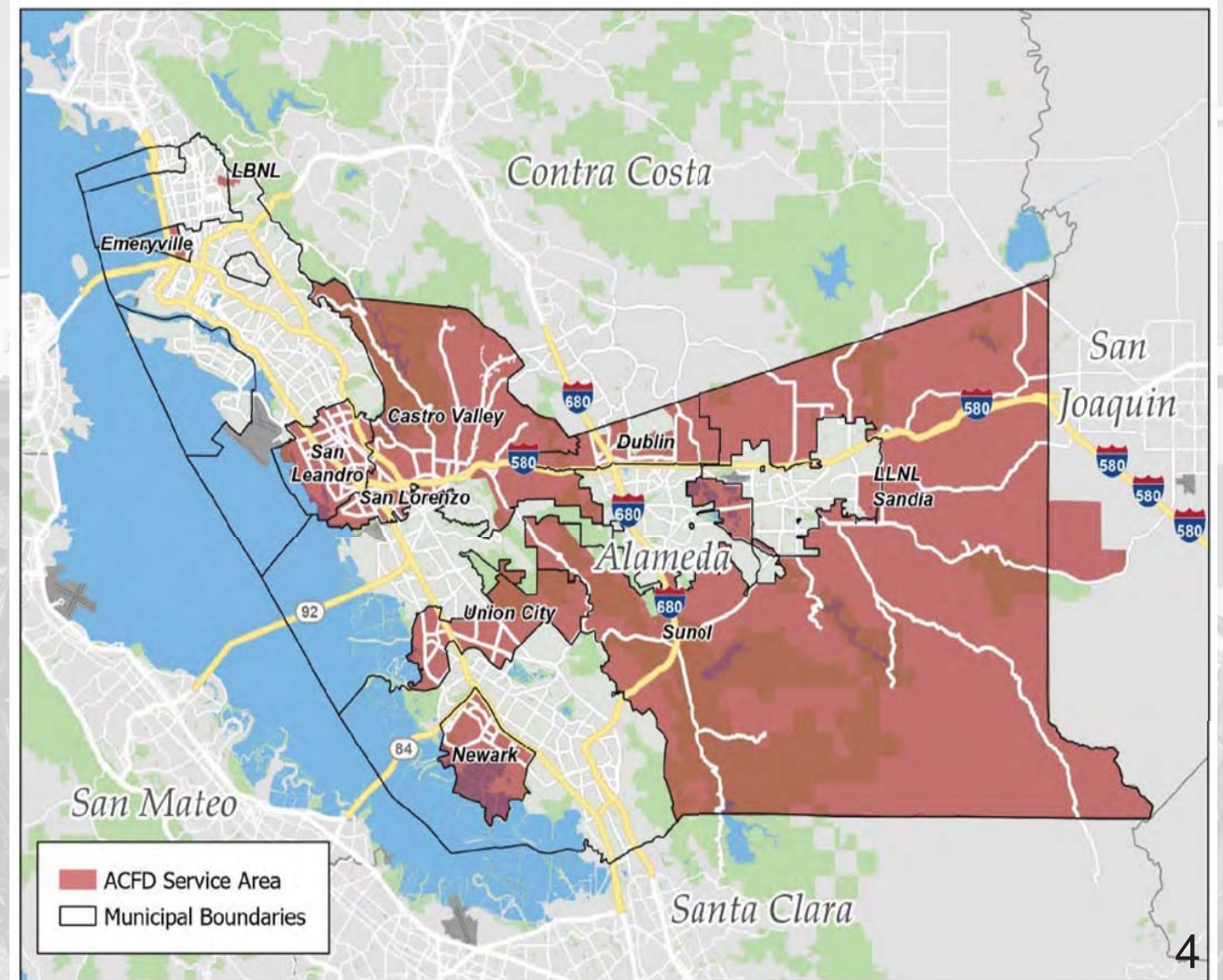
- Dependent district formed under Fire Protection District Law of 1987

- Executive Management Oversight Committee (EMOC)





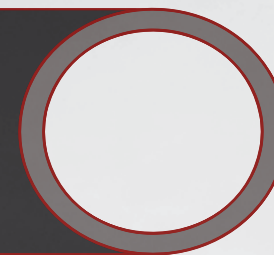

- 911 Dispatch Services





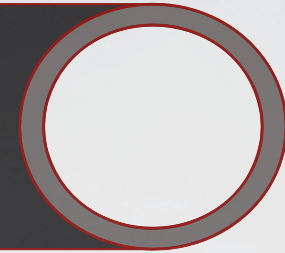

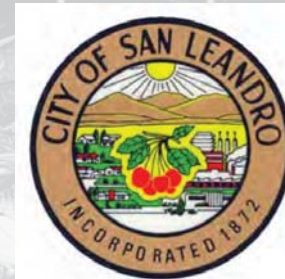
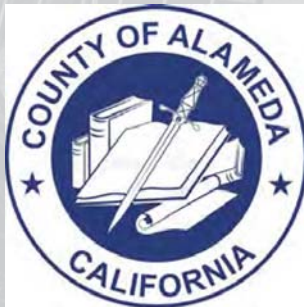




FUNDING

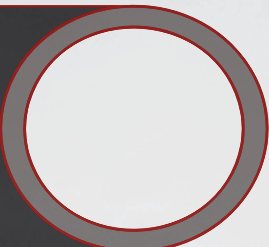


- ACFD revenue sources include assessment tax, service contracts, and grants

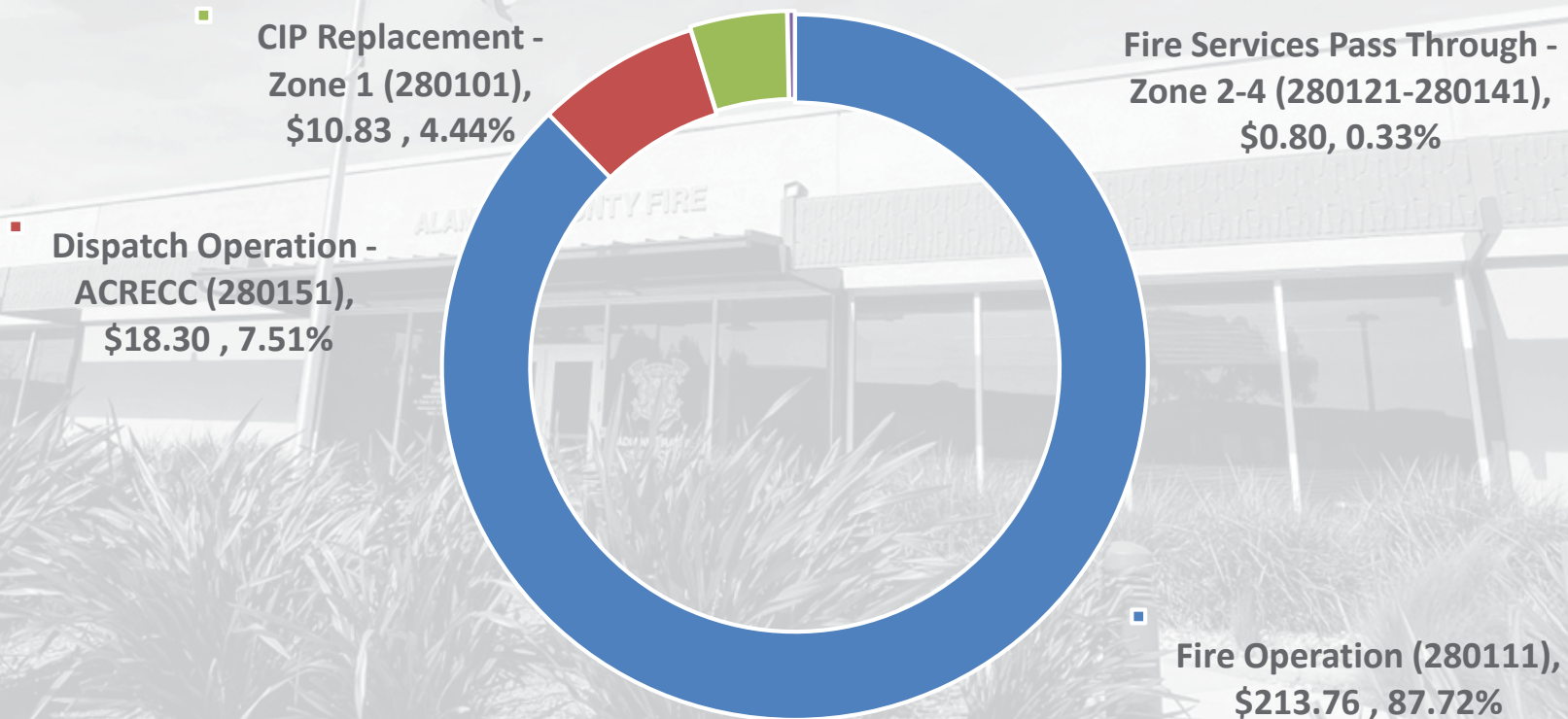

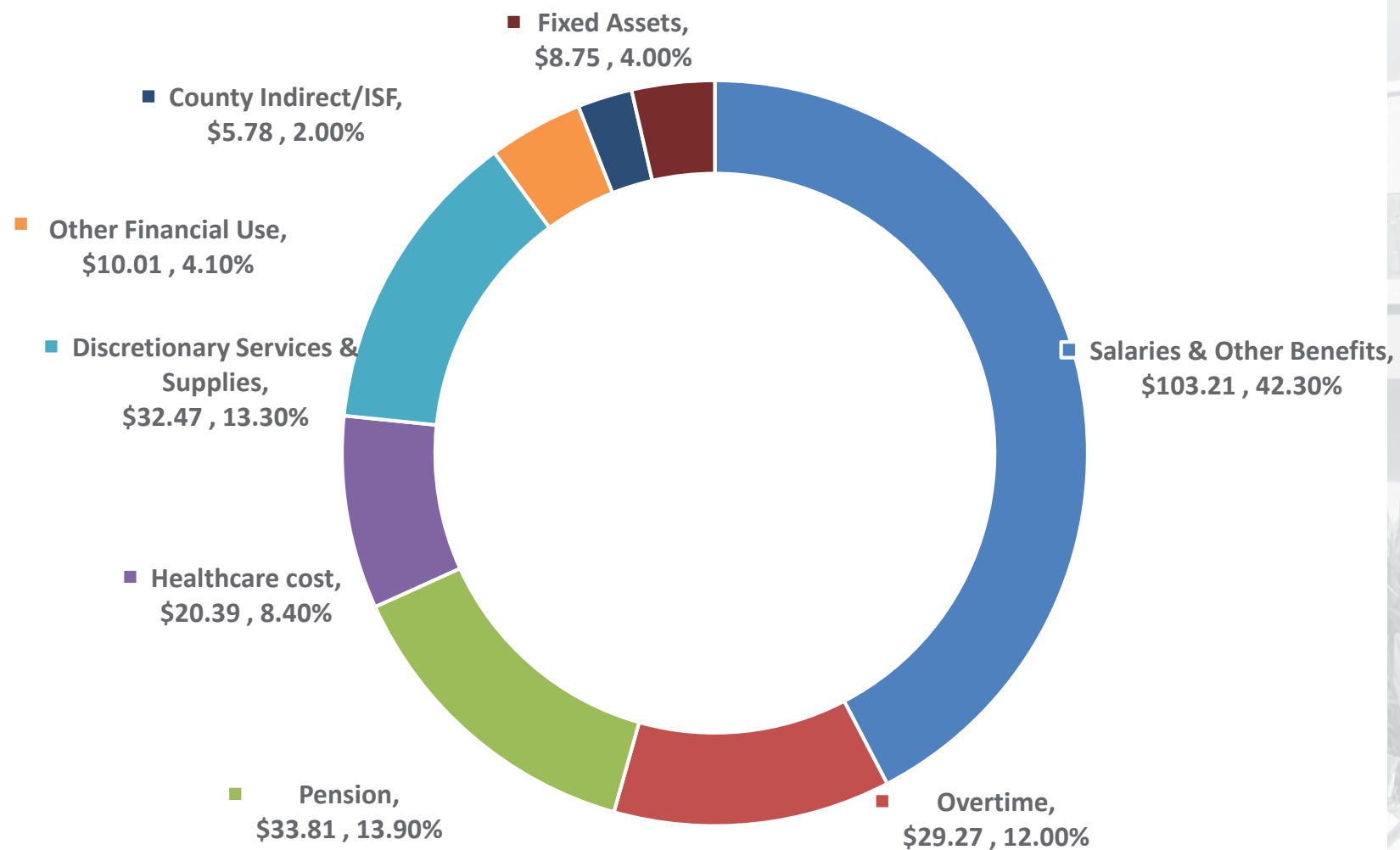

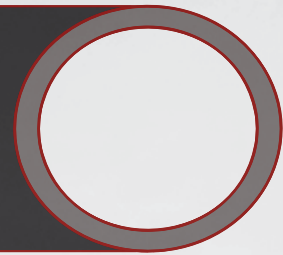
APPROPRIATION BY MAJOR OBJECT

Total Appropriation : \$243.69M

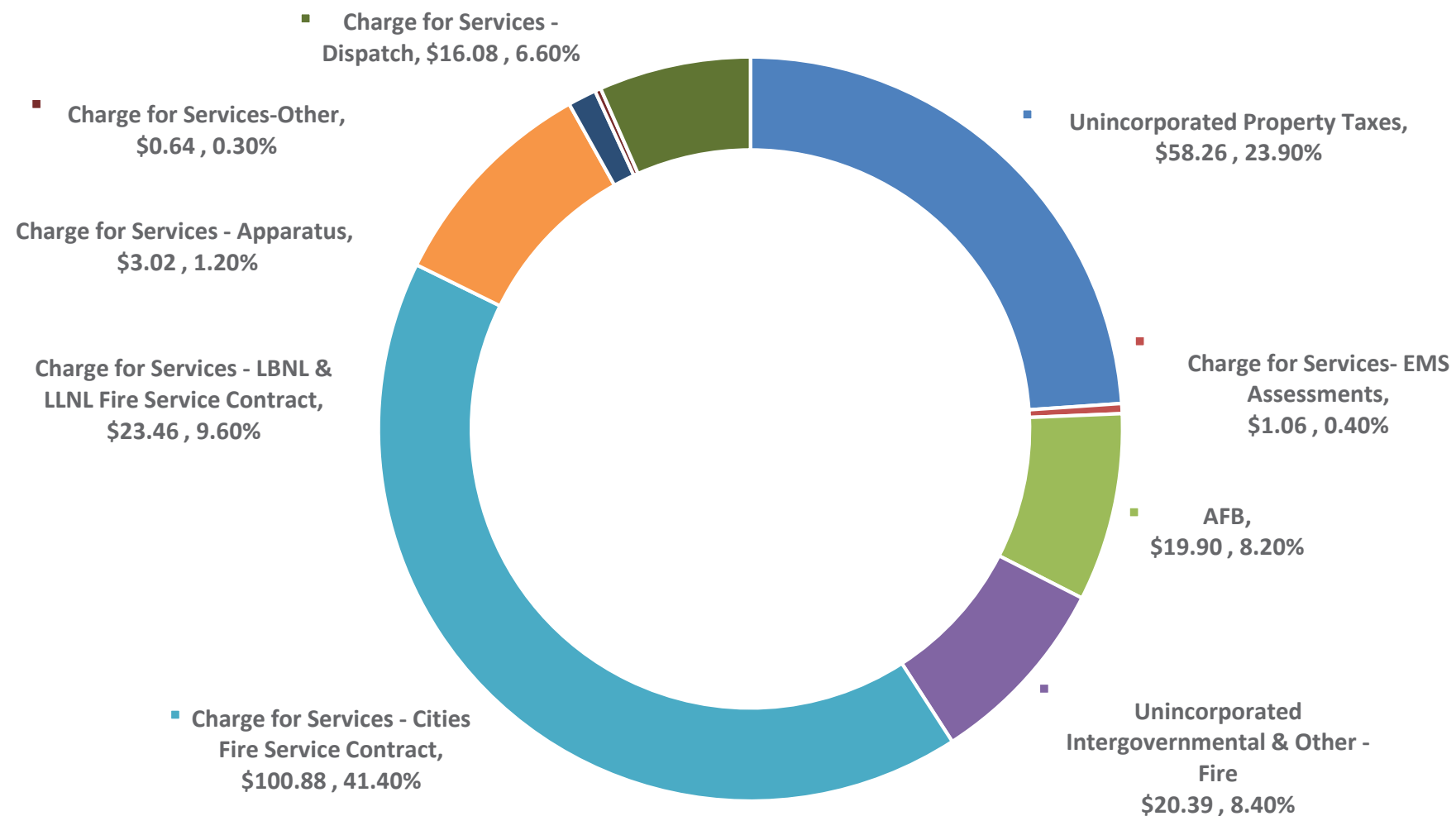




TOTAL REVENUE BY SOURCE

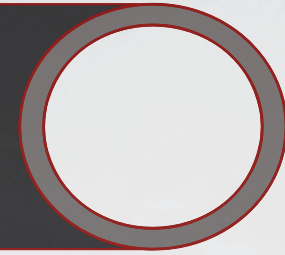

- Reduction in funding availability



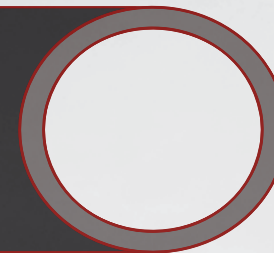
Other Pending Factors

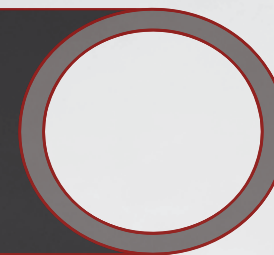

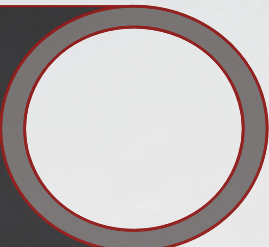


Alameda County Fire Training Tower Groundbreaking April 4, 2025 Dublin, CA

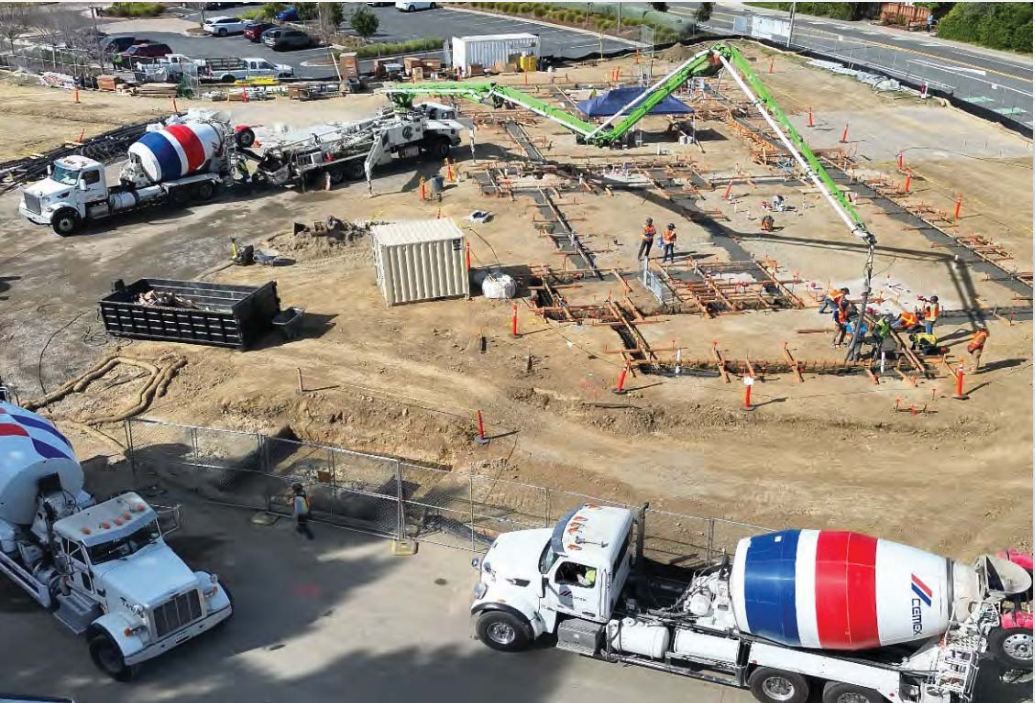

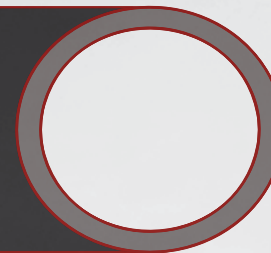

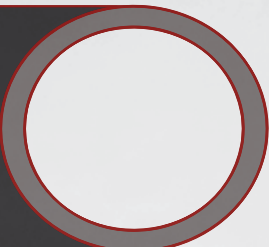
