## **Summary/Action Minutes**

## I. Federal Legislative Update - CJ Lake

#### Schedule

The House and Senate are in session this week. The House is in a committee work week and will focus on markups of the pandemic relief package, and the Senate will see the beginning of President Trump's second impeachment trial and continue working on the confirmations process.

## **Presidential Cabinet Confirmations**

Last week, the full Senate confirmed Pete Buttigieg to be Transportation Secretary (86-13) and Alejandro Mayorkas to be Homeland Security Secretary (56-43). Senate Committees held confirmation hearings last week for Miguel Cardona for Education Secretary, Michael Regan for EPA Administrator, and Marty Walsh to be Labor Secretary. Linda Thomas-Greenfield for UN Ambassador, Jennifer Granholm for Energy Secretary, Tom Vilsack for Agriculture Secretary, Gina Raimondo for Commerce Secretary, Denis McDonough for Veterans' Affairs and Marcia Fudge for HUD Secretary were advanced to the full Senate for confirmation. Neera Tanden's hearings to be director of the Office of Management and Budget are scheduled for Tuesday and Wednesday of this week.

## **COVID Relief Package and Budget Resolution**

The House voted 219-209 on Friday to adopt the same budget resolution senators had approved 51-50 early that morning. The resolution serves as an outline for Biden's coronavirus relief plan, providing reconciliation instructions that could allow senators to pass the final bill with a simple majority rather than 60 votes. With the budgetary portion of the \$1.9 trillion COVID-19 relief package completed, House and Senate committees will spend this week marking up the legislation itself. Twelve House authorizing committees are directed to draft their portions of the bill and send it to the Budget Committee by Feb. 16, with an expectation of a floor vote by the week of February 22.

Speaker Pelosi has expressed confidence that the House will be done with their work and ready to send the bill to the Senate by the end of next week. The rapid pace is due in large part to the fact that Democrats want to provide boosted unemployment benefits by the time current measures expire on March 14. So far, House committee prints have been released by the Committees on Education and Labor, Financial Services, and Transportation and Infrastructure.

The House Education and Labor Committee have also released a Fact Sheet and a Section-by-Section document. The Ed and Labor section of the reconciliation package includes a provision that would increase the federal minimum wage from \$7.25/hour to \$15/hour by 2025 and guarantees that tipped workers, youth workers, workers with disabilities are paid the full federal minimum wage. It is unlikely if this increase will pass muster under the Byrd rule. The draft also includes \$130 billion to help K-12 schools safely reopen, extend P-EBT by \$5 billion, and subsidize COBRA insurance for newly unemployed individuals.

The House Financial Services Committee draft includes \$10 billion to use the Defense Production Act to produce masks and other Covid-19 equipment, \$25 billion for rental assistance, and \$5 billion in emergency housing vouchers and \$5 billion in homelessness assistance.

The Transportation and Infrastructure Committee draft includes \$30 billion in additional relief for the transit sector, \$1.5 billion for Amtrak and \$8 billion for U.S. airports as part of the stimulus package The

#### **Child Tax Credit**

Democrats will be taking the next steps in their effort to expand the Child Tax Credit this week. Today, top Democrats will today introduce a one-year measure that would allow for monthly payments to families with children, worth \$300 per child for kids under 6, and \$250 per child for dependents between 6 and 17. Democrats will also introduce a permanent expansion of the child credit along those same lines. The Democrats' one-year proposal would delay any payments until July, to give the IRS time to get into position to deliver monthly payments. It is believed that this might be included in the budget reconciliation process that Democrats are using to pass the \$1.9 trillion COVID-19 relief bill.

Also of note is the informational hearing scheduled for Wednesday where the Assembly Accountability and Administrative Review and Assembly Emergency Management Committees will delve into COVID-19 vaccine distribution. Legislators continue to introduce bills as we head toward the February 19<sup>th</sup> deadline. The Governor is scheduled to hold a press conference today at the San Diego mass vaccination site. Proposed budget trailer bill language continues to be released and can be accessed on the Department of Finance web site.
