# **Summary/Action Minutes**

I. Upholding Due Process and Protecting Civil Rights of Immigrant Residents Resolution – Action Item Attachment

Supervisor Richard Valle, District 2, Board of Supervisors, presented the Resolution for Upholding Due Process and Protecting Civil Rights of Immigrant Residents and invited input from various County departments, immigrant rights organizations and the public.

Laura Polstein, Centro Legal de la Raza, presented a PowerPoint presentation on Immigration Enforcement in Alameda County jails.

Deportations under the Obama administration have increased significantly, at approximately 2 million, compared to 2 million deportations between 1892 and 1997. Unlawful deportations and detainers increase family separation and immigrant families suffer undue violence for fear of calling police for fear of deportation.

The Immigrant Legal Resource Center requests the Board of Supervisors to pass a resolution to uphold due process and protect civil rights of immigrant residents and urge the Sheriff's Office to change its policy regarding reporting immigrants to the Immigrations and Customs Enforcement Agency.

### II. AB 109 Public Safety Realignment Funded Housing Programs - Action Item

#### Attachment

Linda Gardner, Deputy Director, Housing and Community Development Agency, presented a PowerPoint presentation on the Realignment Funded Housing Programs.

The Realignment Housing Program started in August 2012 as a PRCS housing pilot to flexibly respond to different needs including emergency shelter, temporary housing, assistance in securing permanent housing, short-term rental and other financial assistance. The Housing & Community Development Agency received referrals from the Probation Department, Santa Rita Jail and the Transition Day Reporting Center.

Men of Valor Academy, a community based organization was previously funded by the Probation Department and was moved to AB 109 Realignment housing program in fiscal year FY15/16. It is a site-based 12 month program with support services, including 56 unduplicated clients with 4,329 bed nights.

Community Development Agency requests \$2.23 million in funding to continue housing programs for the realignment population.

#### **III. Inmate Education Services**

#### Attachment

Lieutenant Cheri Nobriga, Sheriff's Office, Umiika Wright, Procurement & Contract Specialist, General Services Agency, presented a PowerPoint presentation on the Inmate Education Services bid process.

Inmate Education Services were established in 1989 when the new Santa Rita Jail was opened. The Pleasanton Unified School District was the first education provider. Classes were academic training and vocational training. In June of 2000, the Tri-Valley Regional Occupational Program contracted with PUSD to provide education services in the jails. This agreement automatically renewed until June 30, 2016.

The contract went out for bid with the following timeline:

  - AC Sheriff, AC Probation, Co-Co County Sheriff,

Tulare County Sheriff's, and Co-Co County Office of Education

➤ 6/24/16 End of Protest period – No protest received

The proposed selected bidder is Five Keys, which provides a minimum of 210 classes per week, not
including Hi-Set and independent study. Hi-Set preparation, testing and independent study at no additional
cost.
