SB 823 Updates

- December 17, 2020 -Initial convening of the Juvenile Justice Coordinating Council (JJCC) Meeting
- January 4, 2021 -Submission of the Board of State Community Corrections (BSCC) Request for Information to inform decision-making and identify counties interested in receiving a one-time grant to provide infrastructure related needs and improvements
- January 5, 2021 - Applications for JJCC vacancies and Subcommittee members distributed to community partners and posted on Alameda County Probation website
- January 20, 2021- Application deadline for individuals interested in serving on the JJCC or the Subcommittee
- January 21, 2021- Convening of the Juvenile Justice Coordinating Council to review application submissions for membership recommendations to the Board of Supervisors

Juvenile Justice Realignment

Community outreach meetings will be held in each district during the course of the development of the comprehensive SB 823 Realignment Plan to gather community input for the plan. A project plan consultant will be contracted to provide technical assistance in the plan development.

Local Department of Juvenile Justice Transfer Plan Details

Utilize Sole Source approach to identify Oakland based community organization due to short-time frame to lead the JJCC Subcommittee, including extensive community involvement, to develop a long-term plan that prevents juvenile justice involvement and reduces ethnic and racial disparities of youth involved in our system.

Establish JJCC Subcommittee

Obtain BOS approval by 3/2021

Move forward with \$3M Community Capacity Fund RFP as quickly as possible to support, strengthen, and invest in community-based organizations who provide services to our at-risk and justice-involved youth.

Speakers

Elana Metz, Vice Chair Juvenile Justice Delinquency & Prevention Commission, working in partnership with the Probation Department, with Bryan Ford, Assistant Chief Probation, Juvenile Division, to invest in community solutions for families.

Emmanuel Pavia, Justice Reinvest Coalition, spoke about keeping youth in the juvenile system, as opposed to transferring them to adult supervision and he hopes that it is supported by the Probation Department.

II. Community Proposal on Reimagining Juvenile Justice

Clarence Ford, Policy Research Associate, Hayward Burns Institute and Erin Palacios, Staff Attorney, Law Center presented a PowerPoint presentation on a Community Proposal on Reimagining Juvenile Justice.

The “Free Our Kids Proposal would design and deliver a plan that: 1) builds capacity for community-based organizations to serve young people outside of the justice system; 2) Results in a significant reduction in the number of young people who are in contact with the justice system; 3) Explores a rehabilitative, health-focused, care-first model of youth justice that is meaningfully different in operations and outcomes from the current system; and 4) prevents the incarceration and prosecution of youth in the adult system.

The Free Our Kids Coalition requests that the “Free Our Kids” proposal be placed on a Joint Health & Public Protection Committee meeting in March to discuss and consider support of the proposal to move to the full Board of Supervisors for adoption.
