
Census Highlights

- County population of 1,510,271, represents an increase of 4.6% from 2000; slower than in previous decades
- Greatest numeric gain in Dublin, followed by Fremont, Livermore, Pleasanton, San Leandro and Castro Valley
- Housing units increased by 42,366 (7.8%) during the same period
- Oakland's population decreased by 8,760 despite adding 12,202 units
- Black/African American population decreased countywide by 23,982 (-11.2%) and decreased by 32,989 (-23.2%) in Oakland
- Asian population increased by 93,200 (30.9%) countywide and increased by 33,167 (44.1%) in Fremont
- Hispanic population increased by 62,901 (22.7%) countywide

Redistricting Requirements and Goals


- Each district should have approximately equal population
- The target population for each district is determined by dividing the total population of 1,510,271 by five to get 302,054
- California election code states that the districts shall be "as nearly equal in population as may be..." Case law suggests that the maximum allowable variance -- from the district that is most 'over' the target to the district that is most 'under' -- can be no more than 10%
- California law and the Alameda County Administrative Code stipulate the following factors to consider in drawing districts:
 - Districts should be contiguous and use easily identifiable geographic boundaries
 - Preserve communities of interest
 - Comply with the Voting Rights Act of 1965 to assure fair and effective representation for racial and language-minority groups

2011 Alameda County Supervisorial Redistricting Timeline

- April 4 Publish redistricting website, including Census 2010 data
- April 28 Publish public notices 30 days prior to public hearings
- May 28 to June 10 Public hearings throughout County (at least one in each current district)
- June 10 Deadline for submittal of redistricting proposals to the Board's Ad-Hoc Redistricting Committee
- June 15 The Board's Ad-Hoc Redistricting Committee advises the full Board and public regarding submitted proposals

Timeline (continued)

- June 20 to 24 Possible work sessions to present the proposals
- June 28 Public hearing by Board of Supervisors on proposed plan
- July 12 Final redistricting plan adopted by the Board
- July 26 Second reading of final redistricting plan
