IV. Approval of Minutes - Action Item

V. Debrief of Community Members: Listening Session held on Saturday, May 17, 2025; Lessons learned – Informational item

Commissioners Berry, Gardiner, Sass and Small, who are part of the Listening Sessions Work Group, gave an overview of the Community Members Listening Session held on Saturday, May 17th, at Allen Temple Baptist Church.

The Community Members Listening Session was opened with a prayer from Allen Temple Baptist church member. The Master of Ceremonies for the event was Commissioner Sass, who introduced Commission members and clarified that this was a community event.

The educational presentations were presented, including History of slavery, Jim Crow era in Alameda County, and definitions of reparations. Following the education there was a Q&A and open forum for attendees to speak.

Surveys were completed, mostly handwritten, by 19 attendees, which indicated strong support for reparations.

The preferred forms of reparations include public apology/acknowledgment, memorials or commemorations, scholarships and grants, direct compensation and funding for equity programs.

There were approximately thirty-three (33) community members in attendance, from throughout Alameda County, however most attendees were from District 4.

Listening Session Venues Suggestions: Churches, schools, coffee shops, parks, book clubs, panels, neighborhood councils.

Strengths

- Educational components were appreciated, especially by younger attendees.
- Community expressed strong interest in future sessions.

Challenges & Considerations

- Community members felt uncertain about the Commissions' prior accomplishments and structure—highlighting a need for greater transparency and communication.
- Recommendations included adding demographic questions to future surveys and refining survey questions for better data.
- Emphasize linking past harms to current-day realities to keep the sessions relevant and impactful.
- A noted gap was the lack of engagement with other marginalized communities—seen as a strategic and ethical priority.

Chair Gore presented the budget structure and options to finalize a budget proposal offering three tiers—low, mid-range, and high—to submit to the ad hoc committee.

Budget Structure and Options

• Three Budget Tiers:

Low: \$195,250Mid-range: \$301,800High: \$400,800

The budget was designed to accommodate 6 listening sessions, though a placeholder for 10 sessions was retained for context.

1. **Listening Sessions**: Base cost increased to ~\$18,000 per session; budget reflects six (6) sessions with placeholders for 10 sessions.

- 2. **Technical Assistance and Project Management**: To be handled by ECC, supporting logistics like scheduling, location, and coordination. ECC has already provided quotes and scope of work.
- 3. Data Analysis: A line item for a consultant to analyze departmental equity-related data.
- 4. Online Survey: Budget allocated for deploying surveys during and outside the listening sessions.
- 5. **Community Pop-ups**: Funding added for pop-up outreach efforts events like Oakland's First Fridays, running through November.
- 6. **Report Writing**: ECC will assist in managing and coordinating the report writing process.
- 7. **Social Media Content Management**: Suggested cost: ~\$5,000 for approx. 9 months of support at \$500/month. May use a professional or a stipend-supported student.
- 8. Marketing and Targeted Ads: Proposed addition: \$5,000-\$10,000.
- 9. **Photography and Videography**: Photographer important for social media repurposing; videographer to capture event tone.

XII. Reparations in the news – Informational Item

- Tulsa City Reparations Private Fund -
- AB 57 Dream for All program for housing,
- Berkeley housing near transit

Chair Gore gave an update on Reparations in the news.

Tulsa City Reparations Private Fund - Tulsa City has established a \$105 million private reparations fund. Entirely privately funded—no city, county, or state money involved. To award resources based on harm and reparations reports related to the city's historic injustices. Legal challenges expected.

AB 57 – Dream for All Program - AB 57 enhances the Dream for All program, which uses statewide Capand-Trade funds to support homeownership. Specifically benefits first-time, first-generation African American homebuyers with zero down payment assistance. The bill has passed out of the Appropriations Committee and is moving forward in the legislative process.

Berkeley Housing Near Transit - Berkeley City Council passed a resolution giving priority to African American residents to purchase housing near BART stations. The city has experienced a decline in its African American population over the years, and this measure aims to help preserve community representation.
