The Social Services Agency and the Health Care Services Agency continue to work collaboratively to prioritize the needs of older adults.

Accomplishments in Older Adult Programs and Services

- Legislative tracking and advocacy
- Senior injury prevention, including new resource guide & 2nd year of evidence-based practice
- Homelessness: expanded access to IHSS, public/private action on encampments
- Collaboration with San Francisco County palliative care/hospice steering committee
- Working with safety net on older adult concerns
- Expanded services: Home visitation nurse case management, advance health care planning, meals and nutrition
- AC Care Connect (Whole Person Care Pilot) to include elements for older adults

The Board of Supervisors directed staff to explore alternatives to their proposal for a new Board appointed commission.

The new proposal is an Agency-led Working Group, which would not be subject to the Brown Act, with appointments to the group by the Agency head. The working group does not require a Board action and would create linkages to the Aging Commission. The working group would report to the Board of Supervisors as requested.
