Commercial Eviction Moratorium

- Current Commercial Eviction Moratorium covers unincorporated area
- On March 23, 2021, the Board of Supervisors extended to June 30, 2021
- Same provisions 90 days from expiration to pay back rent; no penalties or fees may be charged

COVID-19 Small Business Recovery Programs

State awards \$5K to \$25K in business grants!

Round 6: Wednesday, April 28th at 9:00 AM through Tuesday, May 4th at 5:00 PM

Eligible applicants: new applicants that meet eligibility criteria and current waitlisted small businesses and/or nonprofits not selected in Rounds 1, 2, 3, 4 or 5.

Grant award: \$5,000 to \$25,000

Details: Applicants not selected to receive a grant in Rounds 1, 2, 3 & 5 do not need to re-apply and will be automatically moved into Round 6. New applicants will need to apply.

Restaurant Revitalization Fund

Registration for SBA Application Portal Opens Friday, April 28, 2021 Applications accepted May 3, 2021 at 9:00 am


The American Rescue Plan Act established the Restaurant Revitalization Fund (RRF) to provide funding to help restaurants and other eligible businesses keep their doors open. This program will provide restaurants with funding equal to their pandemic-related revenue loss up to \$10 million per business and no more than \$5 million per physical location. Recipients are not required to repay the funding as long as funds are used for eligible uses no later than March 11, 2023.

The first 21 days of the program are reserved for priority groups (at least 51% owned)

- Women
- Veterans
- Socially and economically disadvantaged

Eligible applicants:

- Restaurants
- Food stands, food trucks, food carts
- Caterers
- Bars, saloons, lounges, taverns
- Snack and nonalcoholic beverage bars
- Bakeries
- Brewpubs, tasting rooms, taprooms
- Breweries and/or microbreweries
- Wineries and distilleries
- Inns
- Licensed facilities or premises of a beverage alcohol producer where the public may taste, sample, or purchase products

Federal Economic Injury Disaster Loan - EIDL

- Up to \$2,000,000 loan for small businesses and non-profits
- Program expires on December 31, 2021.


