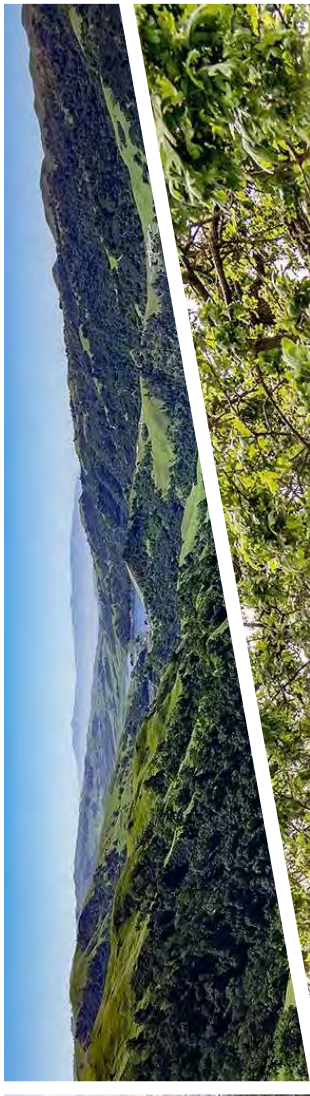
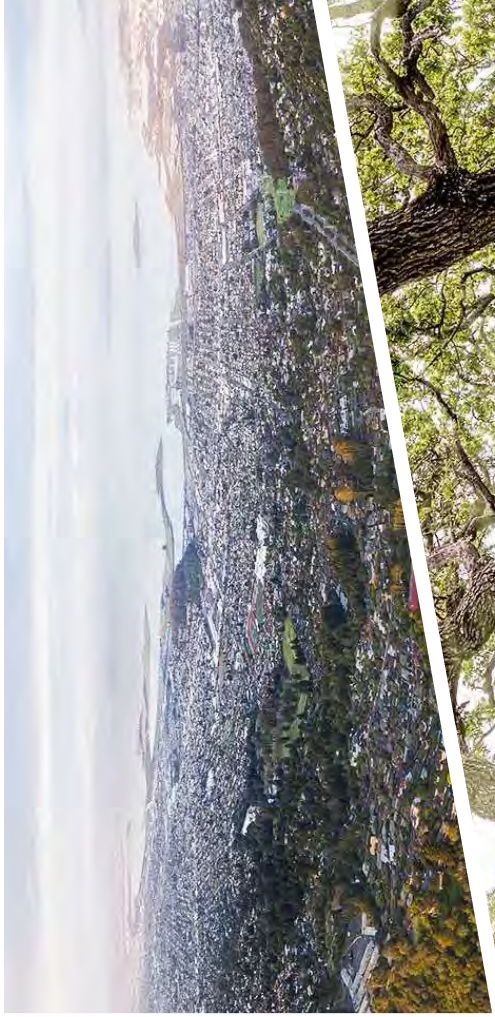

## Community Climate Action Plan and Safety Element Community Workshop #1 Summary, February 16, 2023

On Thursday, February 16, from 6–7:30 p.m. a virtual kick-off for the Alameda County Climate Action Plan was held. Thirty-one people attended the online meeting. The Bilingual Zoom meeting was conducted in Spanish and English with small group discussions. Small-group discussions explored participants' levels of preparedness for the impacts of climate change. Discussion topics included: wildfire and smoke, extreme heat, flooding, and drought. Direct comments from attendees included:

- "Many older people don't have a plan [for extreme heat events] or air conditioning [at home]."
- "Regardless of household [water] conservation efforts, [drought] requires coordinated action by the County and State, [and] even interstate [action]."
- "Dead trees [are a wildfire concern]. [We] need some sort of removal service [and there is] no Tree Board to raise issues to."
- "Flood zone information is outdated or inaccurate and doesn't include climate-related impacts."
- "Many [disaster preparedness] workshops are held in English only. This limits [non-English speakers'] ability to access this information."

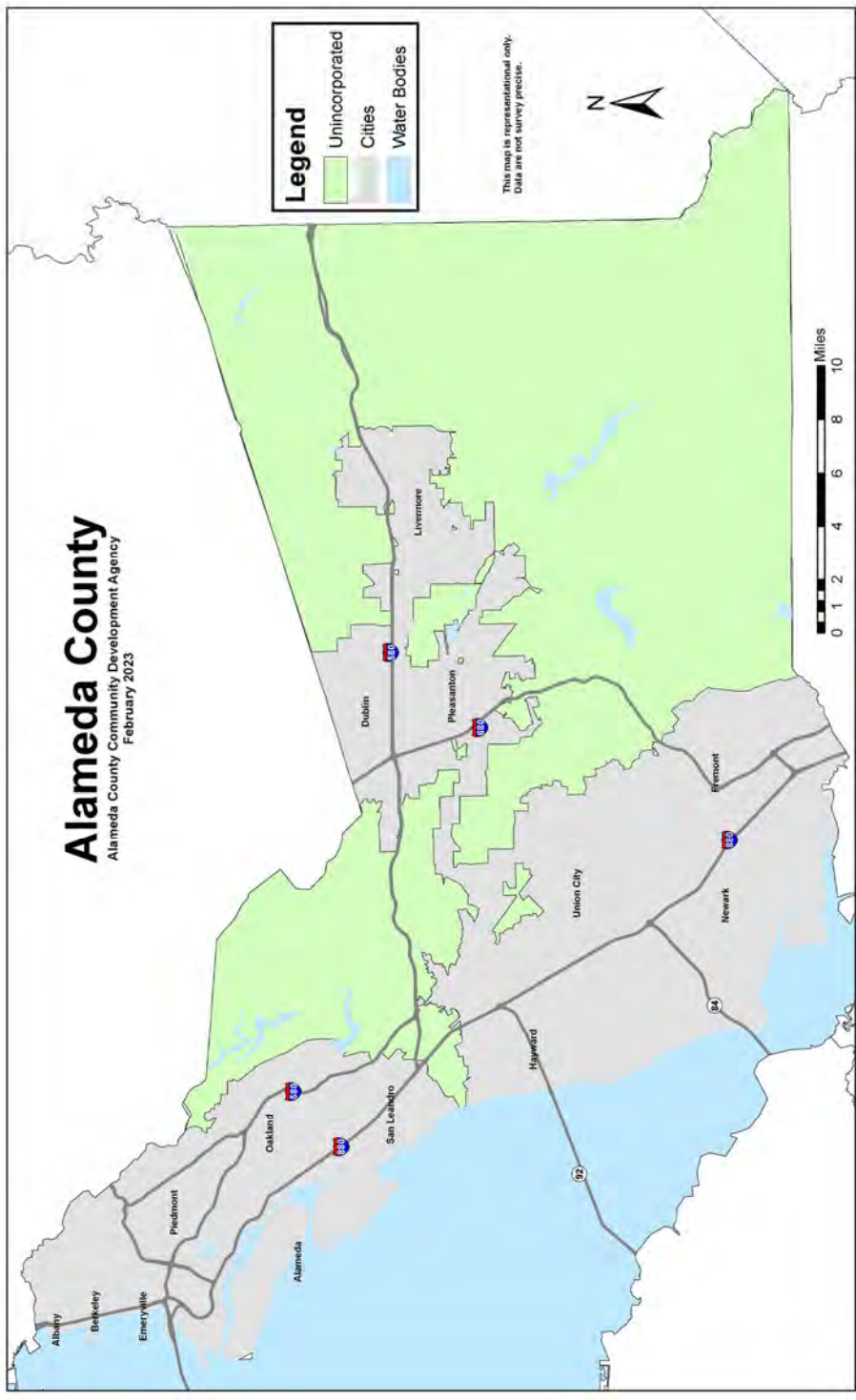

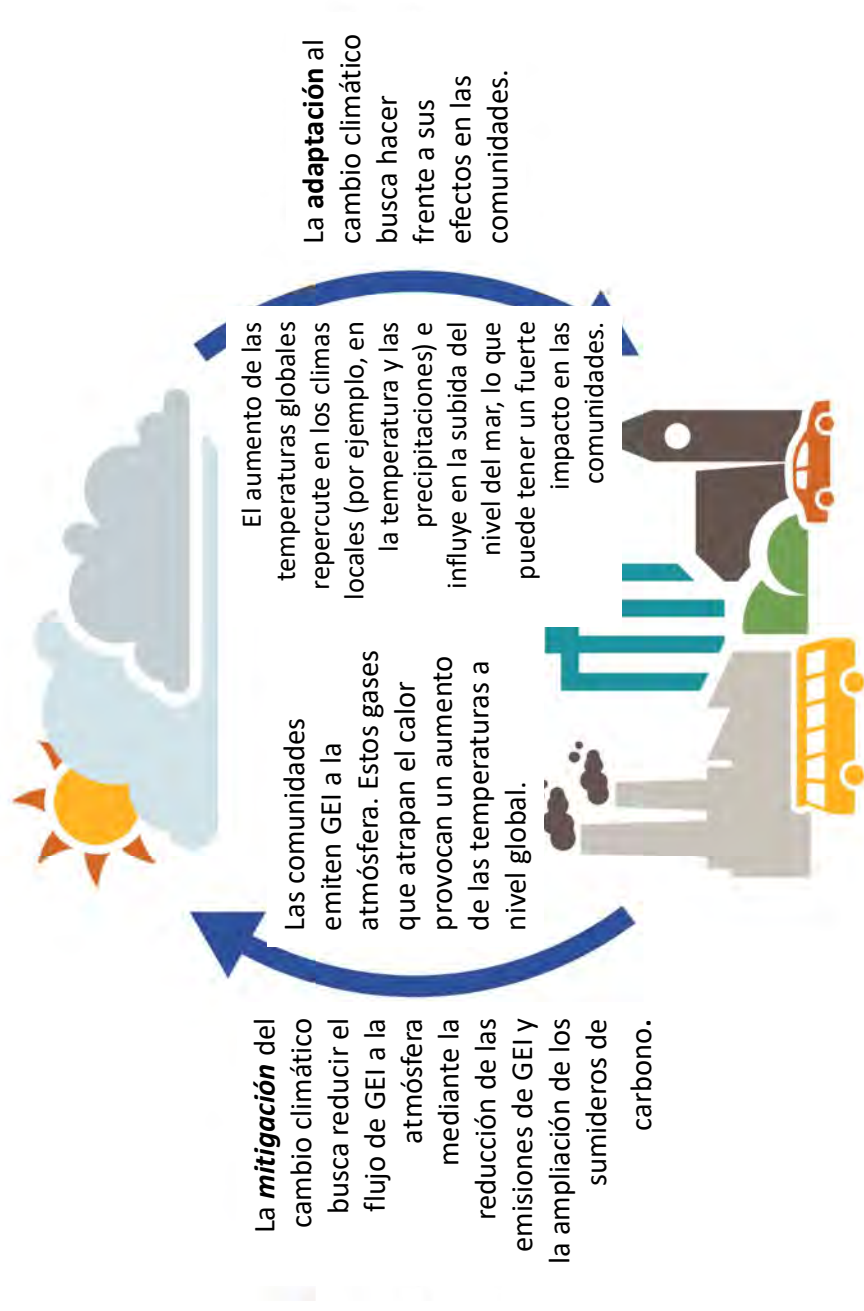
# Climate Mitigation vs. Adaptation / Mitigación del cambio climático frente a la adaptación

## Community Climate Action Plan and Safety Element Community Workshop #2 Summary, June 15, 2023

On Thursday, June 15, from 6–7 p.m. a virtual meeting was held for the Alameda County Climate Action Plan. Seven people attended the online community meeting. The Bilingual Zoom meeting was conducted in Spanish and English. Participants were asked questions about their level of preparedness for the impacts of climate change and answered each question via a poll. Questions included natural hazards, personal countywide impacts participants have felt, and what barriers attendees felt inhibited them from participating in climate action. Direct comments from attendees included:

- "I see the choice under land use of evaluating parking needs and considering using vacant lots for parking. How about offering the choice to residents of considering not paving vacant lots and using them for greenhouse gas purification and clean oxygen production, e.g., environmental protection forests (Miyawaki Forests)?"
- "What do I need to do NOW to move a ball?"

# Alameda County Community Climate Action Plan and Safety Element Update

## Frequently Asked Questions

### What is the Community Climate Action Plan?

The Community Climate Action Plan (CCAP) is a roadmap for reducing greenhouse gas emissions and adapting to the effects of climate change.

### What is the Safety Element?

The Safety Element is part of the Alameda County General Plan that identifies hazards and includes strategies to reduce and manage the risks posed by those hazards.

### Why is Alameda County developing the CCAP and Safety Element Update?

Alameda County's first CCAP was approved in 2014 and focused on reducing greenhouse gas emissions by 15% below 2005 levels by 2020. The State of California has adopted longer-term targets such as reducing greenhouse gas emissions 40% below 1990 levels by 2030 and achieving carbon neutrality by 2045. This update to the CCAP will align with these state goals and provide a holistic climate action approach to both reduce greenhouse gas emissions and adapt to the impacts of climate change.

Since the last Safety Element was adopted in 2017, there have been legislative requirements that enhance what local governments need to include in their Safety Elements. This update to the Safety Element will address those legal requirements, which focus on climate adaptation and resilience and identifying emergency evacuation routes. The County is preparing these documents in parallel to make sure they are consistent.

### Does the CCAP include the cities in Alameda County?

No. This CCAP only includes the unincorporated areas of Alameda County. Many of the cities within Alameda County have prepared their own climate action plans, or are in process of doing so.

### What is the timeline for this project?
