Only those issues which are brought up at the public hearing described in this notice, or in written correspondence delivered to the LAFCo Commissioners at or prior to the hearing, may be raised in any legal challenge to the actions taken by the Commission.

## <u>DISCLOSURE OF BUSINESS OR CAMPAIGN CONTRIBUTIONS</u> <u>TO COMMISSIONERS</u>

Government Code Section 84308 requires that a Commissioner (regular or alternate) disqualify herself or himself and not participate in a proceeding involving an "entitlement for use" application if, within the last twelve months, the Commissioner has received <u>\$250</u> or more in business or campaign contributions from an applicant, an agent of an applicant, or any financially interested person who actively supports or opposes a decision on the matter. A LAFCo decision approving a proposal (e.g., for an annexation) will often be an "entitlement for use" within the meaning of Section 84308. Sphere of Influence determinations are exempt under Government Code Section 84308.

If you are an applicant or an agent of an applicant on such a matter to be heard by the Commission and if you have made business or campaign contributions totaling \$250 or more to any Commissioner in the past twelve months, Section 84308(d) requires that you disclose that fact for the official record of the proceeding. The disclosure of any such contribution (including the amount of the contribution and the name of the recipient Commissioner) must be made either: 1) In writing and delivered to the Secretary of the Commission prior to the hearing on the matter, or 2) By oral declaration made at the time the hearing on the matter is opened. Contribution disclosure forms are available at the meeting for anyone who prefers to disclose contributions in writing.

City of Pleasanton Annexation No. 152 (Martin Avenue Buffer Zone) The Commission will consider a reorganization proposal filed by the City of Pleasanton to annex one parcel (Assessor Parcel Number 946-1151-11-6) of approximately 13.26 acres to the City of Pleasanton to facilitate continued maintenance and use of the property for public recreational and pedestrian purposes with concurrent detachment of the same territory from the Alameda County Library District and the Alameda County Fire Department. The subject area is generally located between Kaiser Sand and Gravel Rock Quarry to the east and Martin Avenue to the west, and between Mohr Avenue to the south and Mohr Elementary School to the north.

7. City of Pleasanton – Staples Ranch Reorganization No. 149 – The Commission will consider a reorganization application filed by the City of Pleasanton to annex approximately 163 acres to the City of Pleasanton to provide municipal services to proposed development with concurrent detachment of the same territory from the Livermore Area Recreation and Park District, the Alameda County Library District and the Alameda County Fire Department. The reorganization also includes annexation of 0.13 acre to and detachment of 0.12 acre from the City of Livermore to clarify jurisdictional responsibility related to future El Charro Road improvements. The project area is generally located south of I-580 and the city of Dublin, west of El Charro Road and the City of Livermore, north of the Arroyo Mocho channel and unimproved quarry lands, and east of the City of Pleasanton.
