**ALAMEDA COUNTY SECURED ROLL PROPERTY TAXES
DUE FOR THE FISCAL YEAR 2025-2026**

More than 447,000 secured roll property tax bills for Fiscal Year 2025-2026 amounting to \$6.1 billion are being mailed this month by Alameda County Treasurer and Tax Collector, Henry C. Levy, to all real property owners of record in the Alameda County Assessor's Office.

The secured roll taxes due are payable by November 1, 2025, and will be delinquent by December 10, 2025. You can also pay in two installments. The first installment is due on November 1, 2025, and is delinquent at 5 p.m. on December 10, 2025, after which a 10% delinquent penalty will be assessed. The second installment is due on February 1, 2026, and is delinquent at 5 p.m. on April 10, 2026, after which a 10% delinquent penalty and \$10 cost will be assessed.

There are several payment options that are fast, convenient, easy and will reduce any unnecessary contact by coming into the office:

- by eCheck, available **free of charge** 24 hours a day online at <https://propertytax.alamedacountyca.gov/>
- by credit card with a fee, available 24 hours a day by telephone through IVR at 510-272-6800, or online at <https://propertytax.alamedacountyca.gov/>
- by mail or drop box for **check payment only** at the entrance of the County Administration Building located at 1221 Oak Street, Oakland, CA 94612, between 8:30 a.m. and 5:00 p.m., Monday through Friday, holidays excepted. **Do not drop cash in the drop box.**
- by the mail slot for **check payment only** at the Business License Office in Hayward, 224 W. Winton Ave., Room 169, Hayward CA, 94544 between 8:30 a.m. and 5:00 p.m., Monday through Friday, holidays excepted. **Do not drop cash in the mail slot.**
- Our mailing address has changed. We are now using the services of a lock box, and your payments will be mailed to Henry C. Levy, Treasurer and Tax Collector Alameda County, PO Box 45862, San Francisco, CA 94145-0862. Your correspondence not related to your tax payments should continue to go to our physical address at 1221 Oak Street, Room 131, Oakland, CA 94612.
- Please note due to safety recommendations from the U.S. Department of the Treasury, some foreign addresses may no longer be able to make online payments. We apologize for any inconvenience this may cause. However, there are still alternative methods available for submitting your timely payment including using the IVR system to pay with a credit card, mailing in your payment as we honor the United States Post Office postmark as receipt date (not the date mailed from the foreign country) or wiring in your payment.

Real property owners who do not receive their tax bill by November 10, 2025 should contact Tax Collector's Office by calling (510) 272-6800, writing to the office, or downloading an internet copy at

<https://propertytax.alamedacountyca.gov/> as per Revenue and Taxation Code Section 2610.5, failure to receive a tax bill does not relieve the taxpayer of any penalties or interest that accrue for non-payment.

Tax bills received for property no longer owned should be forwarded to the new owner or returned to the Tax Collector's Office.

SUPPLEMENTAL TAX BILLS are additional tax liabilities due to a reassessment of property values and the due dates are on the bills mailed to property owners. Please check the due dates on the supplemental bill to ensure timely payment of the tax as these dates may differ from the secured roll due dates.
