Services available include: housing case management, emergency shelter, transitional housing, assistance securing long-term housing and short-term rental assistance, if needed. Flexibility allows responsiveness to the needs of participants.	TBD	Round 1: ACPD is negotiating contracts with 3 vendors: BACs, BOSS and Lao. The Board approved a pool of providers on 7/13/2021. Early Intervention Court	Rebid		With Programs & Services Workgroup (September Meeting) for Logic Model. SOW will be developed from Logic Model.
