Title/Subject Description: Fair Chance Housing Community Education & Outreach Initiative

Background (brief): Vendor – Justice Cities. With COVID outbreaks escalating in prisons and jails and California policy changes to release certain prisoners early on top of the pre-existing condition of the prison to homelessness pipeline, it is of critical importance for formerly incarcerated residents and their family members to know about their new rights under the recently passed Fair Chance Housing laws in the Cities of Berkeley and Oakland and how to access support resources. The proposed community education and outreach efforts will result in Alameda County re-entry residents being able to access housing with their family members or on their own and prevent homelessness, as well as COVID spread.

Fiscal Impact, if any: Outreach Budget: Year 1 - \$82,500 and Year 2 - \$93,500; Research Budget: Year 1 - \$77,000 and Year 2 - \$77,000. TOTAL = \$330,000
