Personally I was a nanny for ten years for four families and enjoyed supporting their development and skill building both in their home environment and in the community on outings I worked with youth as a school-based therapist and also in previous work conducting research for schools receiving grants for after school wellness activities as a diversion program. I have worked with youth and families as an in home behavioral therapist supporting children with severe emotional disturbances as well as spectrum and ADHD disorders among others. I have worked serving youth in foster care and supporting their resource parents in establishing bonds and boundaries while navigating reunification goals with their biological families.

I believe the my attention to the heart and mental wellness of youth and our families helps from a collectivist point of view helps bring the many areas of our work together. With my history of serving youth in private and public programming as well as in community based organizations and in communities with high needs I am able to think creatively and thoughtfully.

I have a passion for being of service to my community and especially to our youth whom are most vulnerable to the gaps in our societal arrangements and in our non-stop demands on working families. I come with heart and respect for all and with a hope to provide my experience in shaping the ways that our youth are best served through our systems of care. I hope to bring unity and warmth to our offerings as partners in the spirit of youth wellness and family stabilization by sharing resources and showing up with the collective coordinating council for our youth.

What are your objectives or goals for the Juvenile Justice Coordinating Council and your expectations as a member?

I would like to see more collaboration and a clear path for best practices around supporting youth in need.

I see my role as a thought partner in service of the youth and families. I expect to show up and have discussions about the shortcomings of our systems, as well as to celebrate the successes of our program offerings. I aim to support opening up more communication as a network. These to deepen connection with the school system

and the probation officers and JJC therapists to offer key programming to lift our youth before, during, and after being involved in the justice system.

I have served communities of diverse backgrounds for over 20 years and that has allowed me to appreciate the various needs each individual, family, community and culture has.

I have been fortunate to have been trained in many different approaches while working with youth and families including trauma informed systems, motivational interviewing, and orisis prevention and interviewing

among many others; which all have included considerations for the various needs of our youth and families including language, religion, tradition and customs, human lifespan, development,

socioeconomics, environmental, and more. This has enabled me to be open and seek to understand first and lead with curiosity. I am of the mind that each family knows their needs best, and I am here to offer tools.

to support their success however they define it. I am supportive of the various walks of life that our community come with and lean into their experiences to best learn about how our offerings can meet their needs.



#### What do you believe are some of the primary obstacles facing youth in Alameda County?

Some of the primary obstacles include a lack of safe and consistently clean and well kept spaces for youth to play and spend time in. For example, parks without lighting or locked gates and limited access to basketball courts and soccer fields as well as over flowing trashcans and lack of benches and seating and shade. As a community we need spaces for youth to play and engage and interact with each other to learn about each other and learn to enrich each other's experiences. Additionally, we have high rates of poverty and a lack of proper resourcing for safe housing, for food security, and overworked and tired parents no matter how hard they are working. We have youth being displaced due to rent increases and families struggling to maintain shelter and there is a lot of stress in households today that is compounded by community violence. Complex trauma is a primary obstacle because it takes time to heal from and our services do not address this quickly enough or to the fullest capacity due to funding.
