 - i. Will we be splitting into small groups
 - 1. Answer: Yes
 - ii. Will we be considering sending youth out of county; concerns around distance, differences in values & standards
 - Answer: Priority to not send youth out of AC. Priority to keep youth close who have to be sent out of the county. Support families who have youth sent out of the county. BSCC decides/approves regional hubs. Will award funding to four hubs. Alameda County does not intend to become a regional hub.
 - iii. Can we clarify the intent of the Phase A plan
 - 1. Phase A plan is an interim plan that focuses on immediate needs of the realigned youth & the preparation that the County needs to do to be ready. Phase B plan will build upon and expand, and is not limited by the Phase A plan.
 - d. Longer term planning
 - i. There is long time planning built into plan
 - ii. May, 1, 2023 submit plan for 2024, repeat every 1, plan must be reviewed at least every 3 years
 - iii. Chief Still: should review every year because of the changing population. Budget will also change every year.

 - 1. Answer: This is not in our hands, currently being discussed. We will know more in March, once more decisions have been made

 - 1. Yes; Chief Still can help facilitate access to youth in JJC & under community supervision & Impact Justice has expertise in recruiting young people and their families for participation.
