    - According to the Discrimination (Employment and Occupation) Convention (ILO No. 111), 362 U.N.T.S. 31, *entered into force* June 15, 1960 discrimination is "Any distinction, exclusion or preference made on the basis of race, color, sex, religion, political opinion, [sexual orientation,] national extraction or social origin, which has the effect of nullifying or

impairing equality of opportunity, treatment in employment or occupation of,<sup>1</sup>" and/or carrying out their duties as a board member. This also includes the gratuitous sabotage or undermining of a board member's or person's work performance.

- 2. Board member lodges a complaint with the CAB which in turn analyzes the evidence or the substantive values of the complaint. If the CAB finds that the discrimination or double standards are being practiced on the CAB, according to Article 3, Section 6, "The CAB may recommend removal of any member for actions detrimental to the CAB or the Realignment initiative by a 2/3 majority vote of all the CAB members at any regularly or specially noticed CAB meeting. The recommendation will be forwarded to the Board of Supervisors for final action."

    - i. CAB program different in the 3 major ways-
