This application is being submitted for consideration by the Community Corrections Partnership Executive Committee (CCPEC) at their meeting on Monday, November 17, 2025.

Community Outreach Event Description: We're building a network between Alameda County, their formerly incarcerated population and their CBOs to co-design our AI powered application and platform. This is the first of two events exploring this network with the end goal of building a system that provides insights and data between all three parties.

The two events will explore:

- Event 1: Building tooling for providers -> We will focus on understanding the pain points providers have in delivering their services and coordinating comprehensive care to clients. Our head of product will facilitate the workshop and we invite CBOs and Alameda County to discuss how to create a more connected ecosystem across providers.

- Event 2: AI for navigating reentry -> Introducing our Reentry Navigator to both CBOs and clients and individuals; AI digital literacy training; and inviting feedback and co-designing of the tool.

The CCP is focused on implementing systems change and improving communication between system partners and the community. Our support of the CCP goals is two-fold:

 1. By hosting events inviting the community to talk about the issues they face both as providers and reentrants we are creating a forum that helps the entire community (CCP, reentrants, and CBOs) better understand the needs and problems in Alameda County.
 2. We take this feedback and build technology for the entire Alameda County reentry community furthering CCP's goals in systems change and communication.
 - For reentrants: our platform will guide individuals to essential resources and collect feedback data on experience
 - For providers: our platform will streamline workflows to enable more effective case management
 - Finally, for CCP: our platform will provide data and feedback that hasn't been available before to help understand where service gaps exist and which programs are effective.
