



COMMUNITY CORRECTIONS PARTNERSHIP *Overview*

Purpose

AB 109 expanded the role of the Community Corrections Partnership (CCP), which was originally established by Senate Bill 678. The CCP's responsibility is to create a County-wide plan to reduce recidivism by identifying and implementing needed systems change, improving communication between system partners and the community, supporting community-based organizations that provide support programs and services that address the needs of the Realignment population and determining gaps in services that AB 109-funding can be used to fill.

Executive Committee

Purpose

Whereas the Community Corrections Partnership creates the Plan, the Community Corrections Partnership Executive Committee (CCPEC), established by AB 109, approves the plan, oversees its implementation and is responsible for making AB 109-funding and budgetary recommendations to the Alameda County Board of Supervisors. The CCPEC uses workgroups to come up with programmatic and funding recommendations to help reach Alameda County's public safety goals. All those recommendations are filtered through the community via the Community Advisory Board (CAB) before being considered by the CCPEC.

Eligibility

- **Post-Release Community Supervision (PRCS):** Individuals released from prison for non-serious and non-violent offenses and are not classified as high-risk sex offenders.
- **Penal Code 1170 (h) Eligible:** Individuals charged and under Supervision with an 1170(h)-eligible offense, including individuals sentenced to local prison and placed on mandatory supervision and individuals granted deferred entry of judgment in lieu of an AB 109-eligible offense.
- **Formal Probation:** Individuals on formal probation.
- **Pre-trial Status:** Individuals on pre-trial status.
- **Specialty Court:** Participants in specialty courts with felony conviction.

The CCPEC meets bi-monthly on the third Monday of the month from 1pm to 5pm.
