These new subcommittees are designed to address not only the immediate needs of our clients but also the root causes of disparities, paving the way for lasting change that benefits our clients, their families, and their communities.

This transformation is more than a streamlining—it's an opportunity to clarify and strengthen our purpose. With the launch of the **Ad Hoc Vision and Mission Committee**, we're aligning the CCP's direction to respond to today's realities while anticipating tomorrow's challenges. The committee will help ensure that our commitment to equity, dignity, and shared responsibility continues to guide this work and shape the development of systems that affirm dignity, belonging, and justice for all, now and in the years to come.

Generational Health

The Generational Health Subcommittee will focus on enhancing emotional, mental, and physical well-being while addressing key issues such as environmental justice, housing stability, and access to culturally responsive health services.

This subcommittee focuses on the emotional, mental, and physical well-being of our reentry populations and will impact the following areas:

- Environmental justice
- Housing stability
- Access to culturally responsive health services

FY25 Starting Objectives (Based on our previous CCP Plans):

- Expand behavioral and physical health reentry supports through in-reach, discharge planning, and post-release care linkage.
- Reduce opioid overdoses post-release and coordinate with Managed Care Plans.
- Implement trauma-informed, culturally responsive services across reentry systems.
- Support wellness through data-informed care coordination and peer integration.

Generational Wealth

The Generational Wealth Subcommittee will work to create pathways to financial stability through skill-building, educational opportunities, homeownership, fair chance employment, and increased business and investment opportunities across Alameda County.

This subcommittee is tasked with promoting long-term financial stability and mobility, and will impact:

- Skill-building and education
- Homeownership
- Investment in community
- Fair chance employment

FY25 Starting Objectives (Based on our previous CCP Plans):

- Launch employer education and job fairs (including at Santa Rita Jail) to reduce stigma

and connect talent to opportunity.

- Increase the pool of Fair Chance Employers by at least 20%.
- Use reentry client surveys and focus groups to inform resource development and barrier reduction strategies.
- Develop tools and guides to connect individuals with employment, education, and financial services.
