Youth Crime in Oakland: Partnerships and Strategies Update</p>	<ul style="list-style-type: none"> • A motion for approval of the meeting minutes for July 20, 2023, was made by Christine Gerchow and seconded by Monica Vaughan. Motion passed. • Update provided by Jenny Linchey, Acting Deputy Chief of Grants, Programs, and Evaluation, City of Oakland Department of Violence Prevention (DVP) • There has been an effort to form a partnership between DVP, Probation, Oakland Unified School District (OUSD), and Community Based Organizations (CBOs) to provide support to at-risk youth that are directly in contact with the juvenile justice system. • DVP will implement a process with OUSD where the DVP will receive names of youth and connect them with services. OUSD will also make referrals to services provided by agencies and CBOs. The goal is to connect the youth to Life Coaches and keep them out of the system. <p>Questions: Has OUSD expelled some of those youth? Are they being referred to services? <i>The referrals mostly come from the Oakland Police Department (OPD). Some referrals come from OUSD.</i> <i>There are about nine youth that have been identified by OPD.</i></p>	<p><i>Keep this item on the next agenda</i></p>
