<p>1. Opening Remarks & Roll Call</p> <p>2. Approval of February 6, 2025 Minutes</p> <p>3. Review and Approval of the JJCPA/YOBG Plan</p>	<ul style="list-style-type: none"> A motion for approval of the February 6, 2025 meeting minutes was made by Al Mance and seconded by Sgt. Spencer. No public comment. Motion carries. Action must be taken to approve the annual JJCPA/YOBG plan, which is due to the state by May 1, 2025. A work group has convened to develop a guiding strategy for the upcoming year, outlined in detail starting on page 15, items 1-9. Key areas of change from last year were described. <p>Discussion and Questions: There was a request to add the following goal to the plan for next year: Increasing collaboration and communication between agencies to eliminate duplication of services and service gaps.</p> <p>It was clarified by a council member that in their opinion the support for the OK Program should have parity with support of other Community-based organizations. Probation confirmed that the OK program is a CBO and a non-profit that works toward the goal of supporting Black youth and increasing equity.</p> <p>Public Comments: There was a suggestion to invite the CBOs under contract to JJCC meetings to present their programs. <i>Probation agrees that including CBOs is key.</i></p>

<p>4. <i>Application Review and Selection to fill JJCC Member Vacancies</i></p>	<p>How will the proposed plan changes make it into the contracts with CBOs? <i>RFPs are put out at least a year before contracts expire. The time to make changes is now for future implementation. Additionally, probation is exploring whether language in current contracts will allow some of the proposed changes to happen sooner.</i></p> <p>When do current contracts expire?</p> <ul style="list-style-type: none"> • <i>The Youth Service Center contracts have been in effect for about one year. They are three-year contracts with ability to extend for two years. RFPs will need to be put out in about a year.</i> • <i>The current Local Service Center contracts expire June 30, 2025. Probation is in negotiations to start new contracts July 1, 2025. If the July 1 date is not met, the current providers' contracts will be extended. Services in the new contracts have been expanded.</i> • <i>The work group will continue to meet to work toward achieving the goals in the plan.</i> <p>Do we have negotiating power for the contracts starting July 1? <i>We have to work within the contractual language at this time. The work group is welcome to review and make recommendations regarding language in current and future contracts.</i></p> <p>Is it possible to inquire from contracted vendors if they already address any of the nine proposed items and how they address them? <i>Many of the providers have some of these items embedded in their program. For example, Trauma Informed Care is already in current contracts.</i></p> <p>A motion was made Michelle Love to approve the JJCPA/YOBG plan. Motion was seconded by Monica Vaughan. No public comment. Motion carries.</p> <ul style="list-style-type: none"> • <i>The JJCC body must select candidates to fill the positions expiring on April 30 – Community-based Drug and Alcohol Program representative and At-large Community representative.</i> • <i>The current representatives in these positions will recuse themselves and leave the room during discussion and voting.</i> • <i>It was clarified that the body speaks broadly about types of services provided versus specific providers to avoid conflict of interest issues.</i> <p>A motion was made by Al Mance to nominate Alexis Peculis to the Drug & Alcohol Program representative position. The motion was seconded by Michelle Love. No public comment. Motion carries.</p> <p>A motion was made by Monica Vaughan to nominate Celsa Snead to the At-large Community representative position. The motion was seconded by Brenda Gomez. No public comment. Motion carries.</p>
