<p>1. <i>Opening Remarks & Roll Call</i></p> <p>2. <i>Approval of Minutes</i></p> <p>3. <i>JJCPA/YOBG Consolidated Annual Plan Discussion & Adoption</i></p>	<ul style="list-style-type: none"> • A motion for approval of the January 18, 2024 meeting minutes was made by Christine Gerchow and seconded by Alexis Peciulis. No public comment. Motion passed. • The annual JJCPA/YOBG plan was presented and discussed. • DPN services are available to any youth in the County, not just probation youth. • There was further discussion around measuring CBO success. • There was a suggestion to measure using results-based accountability. • There was a request to differentiate the youth in the report that are able to go home and those that go to an RFA. • It was confirmed that there are always performance measures built into the contracts with CBOs. • There was a request to meet more frequently to do more work to develop the plan. <p>A motion was made by Monica Vaughan to adopt the plan as written. The motion was seconded by Al Mance. No public comment. The motion passed unanimously.</p> <p>Questions: Is there an explanation regarding the steep decline in arrests? <i>We believe there are more preventative and diversion programs that could lead to a decline in arrests. 	<p>How successful are the diversion programs? <i>ACPD does not keep this data. The data is at the PD level.</i></p> <p>Can the probation diversion services fall under the Case Management referral category? <i>Yes, this is possible.</i></p> <p>How is “successful outcome” defined? <i>Participating in services and completing them.</i></p> <p>Do the numbers of participants include non-system involved youth? <i>Most youth participating in the DPN programs are not system involved. Probation has additional, more intense services for youth on probation.</i></p> <p>Where is the Horizons Family Counseling located? <i>Horizon Family Counseling is located in Livermore.</i></p> <p>How is Probation tracking the successful completion of services by probation youth? <i>Probation youth are tracked by Enterprise, our case management system. Non-probation youth statistics are de-identified and tracked by Mobius.</i></p> <p>How are the risk domain and needs determined? <i>They are determined by the YLS risk management tool and the youth’s individual scores.</i></p> <p>Can the body have a copy of the risk assessment tool? <i>Yes.</i></p> <p>When is the risk assessment tool administered? <i>The YLS/CMI is administered at the investigation stage. It must be administered again every six months at the supervision level. It can be administered more frequently if needed.</i></p> <p>Are there any state guidelines on how the money is spent? <i>There is very little state guidance. It cannot be spent on adult programs or capital projects. Money can be used to pay DPO salaries, however, ACPD does not do that.</i></p> <p>Does this money have to be spent this year? <i>All the funding will be claimed by the CBOs.</i></p> <p>How does Probation evaluate the performance of the CBOs? <i>The County is not at a place where the effectiveness of the programs can be evaluated. We are establishing a relationship with UC Berkeley to perform evaluations on all our programs and services, starting with the Adult services. We believe the programs are working due to the declining number of youth at the facilities.</i></p> <p>How are the decisions made regarding the CBOs? <i>They are made through the RFP process and the County Selection Committee. Probation also has data reporting requirements. It is difficult to measure success of preventative programs. Probation is providing Elevate Academy to our CBOs so they can learn more about Evidence-based practices.</i></p> <p>What is the Council’s role in evaluating the plan? <i>The council participated in creating the plan at the beginning. Probation updates the plan annually. This body is a strategic body.</i></p>	<p><i>Provide a copy of the questions to Celsa Snead.</i></p>
