# III. EDUCATION PROGRAM ANALYSIS & RECOMMENDATION

# A. INTRODUCTION & RESEARCH OVERVIEW - Janene Grigsby

- 1. AB 109 Programs are broken down by category on the <u>Active AB-109 Contracted Programs June</u> list; In the Education Category, there are two subcategories: *Education*, which include our Basic Adult Education programs and *Higher Education*, our college programs; today's focus is our Education: GED, High School Diploma, ESL program, etc.
- 2. Research shows the following five components are key to a successful basic education program: Client readiness life course development & assessment driven services; Barrier removal to address unique challenges; GED programs out to be treated as a transition step; Coordination and collaboration of services; Support: peer, financial aid, admissions, mental health, etc.
- 3. Five Keys Schools is the current AB-109 education provider (contract: 2016 thru 2021); funding allocated is approximately \$436,000 per year; Five Key's contract expires on 12/31/21
- 4. A recommendation is being proposed to approve re-bid the Education contract: \$2 million dollar allocation (approximately \$667,000/year) for a new Education RFP with a 3-year contract term

# B. FIVE KEYS PROGRAM OVERVIEW - Dorick Scarpelli, Ashley Koch, and Myeshia Haywood

- 1. Founded in 2003 by the San Francisco Sheriff's Department, Five Keys was the first public high school for adults in the country to operate inside a county jail and currently serves 9 counties
- 2. Five Keys has expanded to include wraparound services like re-entry planning and case management, career pathways, homeless services, and transitional employment; case managers provide counseling support and referrals to other services and they introduce the client to a teacher who helps create an educational plan; Five Keys also relies on around 40 community-based partners, co-locating Five Keys teachers at various community service locations (probation departments, workforce development agencies, young adult agencies, etc.); 25% of Five Keys AB-109 funded program staff are formerly incarcerated, including the Director

#### C. CLIENT FEEDBACK - Rita Gomez

1. Student Rita Gomez shared how Five Keys supported her moving forward in her life, including connecting her with a teacher and outside agencies, and assisting in finding a job

#### D. PROGRAM DATA - Kevin O'Connell

1. Shared draft of the <u>ACPD AB-109 Education Program Overview</u> sheet and requested feedback on format, need and content; the first page of the sheet gives a general overview of the Education program and the second page gives data about the current provider; this model will be tailored for use with other re-entry programs; a suggestion was made to include 1) student's educational level when they enter the program (to show academic progress/increase in grade level); and 2) post-secondary outcomes (went on to college, got a job, etc.)

Who We Reach: Outputs – Clarification that *Accepted* is when the client's referral has been accepted and *Enrolled* is when the client is actually enrolled in services; referrals go through the DPOs; contracted providers can communicate with the DPOs through the Tyler Supervision Provider Portal; Probation is in the process of hiring a Re-entry Services Coordinator specific two education who can assist with the process; A suggestion was made to add a pre-enrollment phase for clients the provider is engaging with (education readiness, barrier removal, etc.), but are not yet enrolled

a. May want to think about re-wording the following outcome: Higher level of education and post incarceration opportunities for the re-entry population
