III. Programs & Services Workgroup (PSW) Plan & Objectives

- A. Based on the [CCPEC Complete Workgroup Outlines](#), *"Programs and Services ensures effective/results-oriented services for the Realignment population..."*
- B. Although it is necessary for the PSW to temporarily focus on developing logic models for programs with previous allocations to ensure transparency and that the community has the opportunity to help develop a program model that meets today's needs, the PSW will not lose focus of its purpose: the PSW will continue introduce new ideas, analyze services, identify barriers to access and service gaps

IV. Program Model Recommendations – Workgroup Participants

A. [Services For Women & Women With Children](#)

1. [Women & Women with Children Logic Model](#)

- a. The allocation for *Women and Women with Children Services* is \$1 million
- b. Program description: To encourage and support women and women with children by offering inclusive and responsive services, which include gender-specific trauma-informed care, mental health programming and support for mothers

2. **Target Population: Who Will the Program Serve?**

- a. The target population is adults 18+, [AB 109 eligible](#), may include: women and those who identify as female; women with children and women who do not have children but are a parent figure to a child
- b. There is a separate allocation of \$100,000 for *LGBTQ Services and Resources*

3. **Inputs/Resources: What Resources/Investments Are Needed?**

- a. With current available services limited for women, this allocation can be used in multiple ways, including funding a single program where many needs are met, or supplementing the

funding for several already existing programs to provide ensure gender-specific services that fill gaps specific to women are offered

4. Activities: What Will the Program Do?

- a. Some basic services that can be addressed: victims of domestic partner violence, substance use, employment, and childcare and transportation; any services not available can be referred to other community-based providers with a specific focus on female needs
- b. Other recommendations: gender-specific employment services; education curriculums designed for women; therapy services extended to children and partners; staffed case managers and peer support; multiple providers and/or mobile service; transportation barrier removal; build services with a framework similar to the peer support program, For Us By Us (FUBU); work with providers that do community outreach; teach financial literacy; support for the client to grow off services; a strong substance use program that does referrals to support other needs and offers barrier removal

5. Outputs/Participation: How Will Program Participation Be Measured?

- a. Program will track the outcome of each referral, and participation and completion data

6. Anticipated Outcomes: What Are the Ultimate Goals of The Program?

- a. Short term: Create a safe space for women to feel comfortable engaging in services
- b. Midway: Personal change through enhanced engagement in treatment/services
- c. Long term: Change in conditions for the client; increased awareness/training on the need for gender responsive services; increased resources and decreased structural barriers for women; reduction in recidivism; and successful transition off services into self-sufficiency
